I have been thinking about how very bogus it was that the MSP attempted to completely scuttle the meeting. Not only do they not keep us up-to-speed, as promised, they won't even meet and look you in the eye.

They told Dad and Chris in great detail about Ted Lamborgine--whom they believed to be the child killer or to have participated. Here is a living suspect, not even charged in these crimes, and they are telling you about his apartment, how his closet is organized, how he separates his coins, how he carries a bible that is highlighted, the church he belongs to, what his pastor said to cops about him, that he has attempted to make a large donation to this church, that he has a living mother and sister, the mother's age, that his roommate in Michigan back in the day was murdered, that he may have been connected up with the Tazalars, who by the way live on Wyndemere or some damn thing, that Tazalar originally was going to take a polygraph or undergo further questioning, but now his doc doesn't want him to because of his heart condition, blah, blah, blah.

Like I said--a LIVING suspect, charged only with unrelated crimes but not in the OCCK case and you get the litany. Oh, and by the way Mr. King, can you file a civil suit against him to help us out here??? In this case you have a DEAD suspect, a DEAD accomplice who died in prison years ago, Daddy Warbucks and his wife are DEAD, and as far as I can tell, anyone else they are remotely interested in talking to is either incarcerated or such a pathetic piece of shit that they could not come up with enough dough to drive to Mexico or Canada. Third, and unlike any of their other suspects, Busch was polygraphed and cleared by the MSP and enough was found at his suicide scene to have his suicide file end up at the task force. When I called Jack K. in early December of 2007 to ask if he remembered a Bloomfield guy who offed himself, he thought for about 20 seconds and then said he did remember a guy who killed himself in Bloomfield Township and that some strange stuff was found at the scene, including a pencil drawing of a young boy screaming who resembled Mark Stebbins. I immediately told Cory about this call with Jack. By the way, Milton tried to FOIA that suicide file from Bloomfield Township for me after she got me Busch's death certificate. The response--the records have been destroyed. But guess what, that file had long ago gone to the TASK FORCE. Somebody in Bloomfield Township figured out this fucker needed to go to the task force. It was obvious to the responding/investigating officers that this needed to be done. The file lands on somebody's desk at the task force, they pull out the case file THEY ALREADY HAD on Busch, and guess what?! Oh fuck! We polygraphed him and cleared him and it was that bozo in Flint who conducted the polygraph! Shit! Oh well, at least he's dead and his buddy is in prison for life.

And why did I have Milton get that death certificate (on Dec. 7, 2007--probably before the MSP) and try to get the suicide file? Because I knew I needed an insurance policy in case those wads decided it wasn't a lead worth pursuing. My buddy from Idaho who is a private investigator has helped me since May 2006. Jack K. has helped me in any way he can. Milton has helped me. I knew I needed help because I knew how they would try to treat this thing--the way they treated Jack Kalbfleisch when he tried to get them to listen. They turned away a valuable resource and luckily he ended up helping me instead of them.

THAT'S why they are scared shitless of losing control of this thing. They have had almost 2 years to work on damage control since they learned that Busch's name floated up to the surface again. And one year to work on that fiber evidence. STOP TAP DANCING and show us the money.

The murder of that family up north in the late 60's was closed with far less evidence than they have here. Read one of the books written on that case--there are still questions about the conclusion. These guys want this thing kept open so that no one can FOIA the case files. I would not put it past them to start destroying records.

And I am still pissed off that they won't invite Kym Worthy. WHAT DO THEY HAVE TO HIDE?

At the meeting I would just keep asking questions. If they won't answer, ask why they won't answer. If they say they "don't know" ask them why they don't know. We are going to end up finding out all about it anyway. These guys are the dumbest bastards ever.
