Gentlemen:

Please be advised that plea negotiations in the above criminal case have, at least temporarily, broken down, inasmuch as, understandably, Judge Borradaile would not commit himself to allow Mr. Busch to remain free on bond pending sentence, nor would he commit himself to sentencing Busch to probation. Trial is now scheduled for September 14, 1977, at 8:30 a.m.

Our office will allow Busch to plead guilty to Assault with Intent to Do Criminal Sexual Conduct Involving Penetration, but we will not enter into a sentence concession whereby Busch will be placed on probation.

Please keep our office advised of the developments in your case.
